

SPEAKER BIOGRAPHIES

THOMAS BOUVET -- Thomas Bouvet is a partner at Veron & Associates in Paris, France. He specializes in patent litigation. He obtained an LLM in the USA and is a doctor-at-law. Admitted to the Bar in 1996, he immediately joined Pierre Véron to practice patent litigation and has been a partner of Véron & Associés since the creation of the firm in 2001. Thomas' activity mainly relates to patent validity and infringement litigation in the fields of electronics, telecommunications, mechanics, chemistry, pharmaceuticals, media and biotechnologies. He has extensive experience in patent entitlement cases and in matters relating to the violation of trade secrets. He defends employers in actions of compensation for employees' inventions and advises companies setting up appropriate policies in this respect. Following his doctorate thesis, Thomas handled a large proportion of cases brought before the French courts for infringement of plant breeder's rights. He has arranged several customs actions. Thomas lectures on patent litigation notably at the EM Lyon School of Management and Centre Paul Roubier.

HON. TILMANN BÜTTNER – Hon. Tilmann Büttner is a judge of the Regional Court of Düsseldorf since 2007 and specialized in patent law. From 2010 to 2012 he was seconded to the Federal Ministry of Justice, where he joined the division for patent law. In December 2012 he has become Deputy Presiding Judge of the newly formed 4c division of the Regional Court of Düsseldorf to which patent infringement proceedings are assigned. He is following the emerging Unitary Patent Court system by lectures and the participation in an annotation project to the new legal texts concerning the Unitary Patent court. He was educated in law at the Universities of Heidelberg and Osnabrück.

JEAN-JACQUES CANONICI -- Jean-Jacques Canonici is a Director & Patent Manager, Innovation, EMEA, and EMEA Household Care, for Procter and Gamble. Jean-Jacques Canonici is a chemical engineer and a qualified European Patent Attorney. His responsibilities include a regional management function for P&G's Patent Group in Europe.
