Since July 2010, Benoît Battistelli has been President of the European Patent Office, an international organization with 38 member states, comprising all the members of the European Union, plus a number of further countries, including Norway, Switzerland, Turkey, and several Southeast European states. His mandate runs until 30 June 2018. A graduate of the Paris Institute of Political Studies (IEP) and the National School of Administration (ENA). Mr. Battistelli beaan his career as a senior civil servant in the French Ministry of the Economy and Finance. Mr. Battistelli, a French national born in Paris in 1950, is married with three children.

These galleries are frequently reinstalled in an effort to feature a wide range of artworks in various configurations, reflecting the view that there are countless ways to explore the history of modern art and the Museum's rich collection.
