



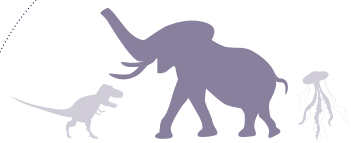

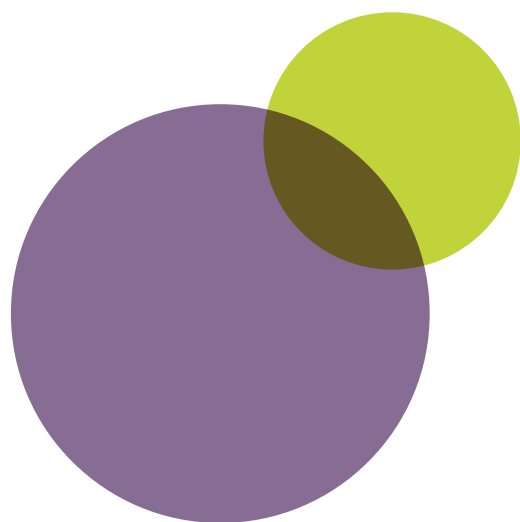



Cathy recently completed her four year term as CEO of Deloitte, one of the largest professional services organizations in the United States. There she led a large transformation across the business by moving the firm towards emerging technologies such as AI, blockchain, robotics, and cloud, including securing ecosystem partnerships with large technology companies, and executing digital acquisitions. Cathy is chair of the Center for Audit Quality Governing Board and, as a strong supporter of diversity and inclusion, the first woman to serve as chair of the Catalyst Board, a global, non-profit organization that promotes inclusive workplaces for women. She is also a founding member of the CEO Action for Diversity and Inclusion.</p></div> <div><p>António Campinos, <i>President, European Patent Office, Munich, Germany</i></p><p>António Campinos took office as the President of the European Patent Office (EPO), an international organization with 38 member states, on July 1, 2018. With nearly 7,000 staff, he leads one of the largest public service institutions in Europe. Headquartered in Munich with offices in Berlin, Brussels, The Hague, and Vienna, the EPO was founded with the aim of strengthening co-operation on patents in Europe. Through the EPO's centralized patent granting procedure, inventors are able to obtain high-quality patent protection in up to 43 countries, covering a market of some 700 million people.</p></div> <div><p>Andrei Iancu, <i>Under Secretary of Commerce for Intellectual Property and Director of the U.S. Patent and Trademark Office, Alexandria, VA</i></p><p>In his role as the Under Secretary of Commerce for Intellectual Property and Director of the United States Patent and Trademark Office (USPTO), Andrei Iancu provides leadership and oversight to one of the largest intellectual property offices in the world, with more than 12,000 employees and an annual budget of over \$3 billion. He also serves as the principal advisor to the Secretary of Commerce on domestic and international intellectual property policy matters.</p></div>

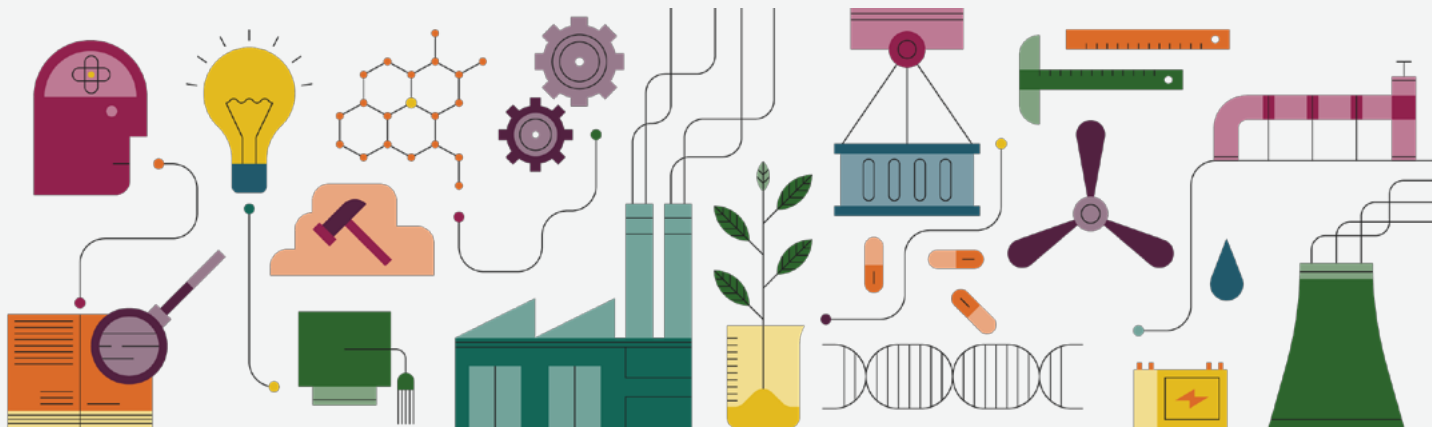
Cancellation Policy
