In advance of updating the Green Guides, the FTC received nearly 60,000 responses to questions it posed about frequently used environmental claims, ranging from "low carbon" to "net zero" to claims concerning the recyclability, sustainability and compostability of products. As consumers have focused their purchasing on environmentally friendly products, brands have expanded their marketing and advertising to include a variety of claims touting their products as safe for the environment. The FTC and courts have also become more focused on ensuring that marketers' "green" claims are truthful and accurate. China implemented PTA as part of the Fourth Amendment to the Chinese Patent Law, which came into effect on June 1, 2021. A decision from the Brazilian Supreme Court in November 2021, seems to have introduced the possibility of PTA for patent owners which demonstrate an unreasonable, unjustified, and exceptional delay of the Brazilian Patent and Trademark Office in granting the patent application.
